There are 3,708 large taxpayers and many are not compliant to the Bureau of Internal Regulation 9-2009 requiring large taxpayers to have Computerized Accounting System (CAS). This compliance will also become a requirement in 2018 for the top 500 identified medium-sized taxpayers for every BIR region.

Compliance to this regulation is a challenge due to the difficulty of the requirements. The BIR created a special task force called Computerized Systems Evaluation Team (CSET), composed of members from the audit, IT, quality assurance and field auditor from revenue district to enforce and to monitor compliance.

This one-day training is to provide guidance and assistance to contractors, construction companies, and property developers -- especially those who are interested to join in government-related projects. Discussion will cover everything from BIR's regulations and rulings, to presentation and actual system demonstration (which is part of the BIR requirement).
