This one-day seminar is a definitive guide on how to efficiently utilize ejectment actions and proven available remedies as effective tools in the speedy recovery of your land and / or building.

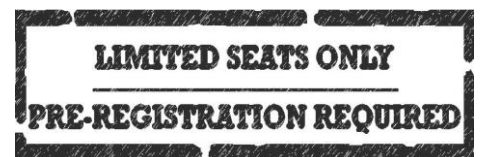

Lecturer 1: Judge Danilo A. Manalastas is the author of "*The Law on Ejectment*", which is currently the most updated book on the subject.
