Resolution No. 1735

WHEREAS, Article IV, Part III of the Integrated Reorganization Plan, as approved under Presidential Decree (PD) No. 1, dated 24 September 1972, and amended by PD No. 336 on 14 November 1973, created the Career Executive Service Board (CESB) to serve as the governing body of the Career Executive Service (CES) with the mandate to promulgate policies, rules, guidelines, standards, systems, and processes for the recruitment, selection, classification, compensation, placement, and the leadership, professional and career development of members of the CES;

WHEREAS, the Board, through Resolution No. 882 on 13 July 2010, as amended by Resolution No. 1281 on 18 May 2016, promulgated and institutionalized the CES Accreditation and Equivalency System (CESAES) for the purpose of promoting and sustaining continuing professional growth, self-development, and capacity strengthening of CESOs and Third Level Eligibles in a purposive, effective, systematic, and efficient manner;

WHEREAS, the Board, through Resolution No. 1516-A on 21 November 2019, Article I section 4-c, required a CES eligible to comply with training requirements which include the completion of accredited training program or its equivalent for CESO Ranks I, II and III;


WHEREAS, Outcome 4, Chapter 14 of the Philippine Development Plan (PDP) 2023-2028 provides that the CES system shall be strengthened through merit and fitness, and continuous upgrading of its program offerings and services for all public officers and employees serving the national government;

WHEREAS, the Center for Global Best Practices Foundation, Inc. (CGBPF) is a non-profit institution established on 6 March 2007 with the vision of spreading the culture of best practices in the Philippines as well as in other countries whose advocacy is to enhance the global competitiveness of individuals and organizations across various industries through best practices initiatives and is continuously involved in research, education, business advisory / consulting, and the search for the Best Practices Award;

WHEREAS, CGBPF is an accredited training provider of the Securities and Exchange Commission (SEC), Civil Service Commission (CSC), Supreme Court of the Philippines, Professional Regulation Commission (PRC), Local Government Training and Research Institutes – Philippine Network, Inc., and the Anti-Money Laundering Council (AMLC);

WHEREAS, CGBPF has completed the submission of the documentary requirements for the grant of accreditation on 28 February 2024;





APPROVED this 12th day of March 2024 in Quezon City, Philippines.




